## **Aether Catalyst Solutions Announces First Tranche of Non-Brokered Private Placement**

Burnaby, British Columbia / April 14, 2023 – Aether Catalyst Solutions, Inc. ("ATHR" or the "Company") (CSE: ATHR)(FSE:2QZ) announces that, further to its news releases dated April 6, 2023 it has completed a first tranche of its non-brokered private placement consisting of the issuance of up to 4,000,000 units (each, a "Unit") at a price of \$0.055 per Unit for gross aggregate proceeds of up to \$220,000 (the "Private Placement"), pursuant to which the Company has issued 3,065,000 Units for total gross aggregate proceeds of \$168,575. Final closing is expected prior to April 21, 2023.

Each Unit consists of one common share in the capital of the Company (each, a "Share") and one-half a transferable Share purchase warrant (each, a "Warrant"), with each Warrant entitling the holder thereof to purchase one additional Share (each, a "Warrant Share") at a price of \$0.10 per Warrant Share for a period of twelve months from the date of closing of the Private Placement.

The gross proceeds of the Private Placement will be used to primarily fund ongoing operating expenses of the automotive program and continued development of the small motors program, where the company is adapting its technology for utilization in the emissions abatement of small motors.

The Company confirms that there is no material fact or material change about the company that has not already been generally disclosed.

The Company paid finder's fees of up to 5% cash on certain placees to Canaccord Genuity Corp. on this tranche of the offering. All securities issued in connection with the Private Placement will be subject to a statutory hold period expiring four months and one day after the date of issuance (the "**Issuance Date**"), as set out in National Instrument 45-102 - *Resale of Securities*.

Aether Catalyst Solutions, Inc. is focused on providing an order of magnitude cost reduction in automotive catalytic converter catalyst, while meeting, or exceeding government emission standards. While Aether's primary focus has been automotive applications, the company is also developing catalysts to address small motors emissions – a significant contributor to urban air pollution.
